Funding Design Background and Context



Funding Design Goals

Develop a funding system for Illinois' early childhood education and care programs that:



Promotes an **equitable, inclusive, family-centered system** of quality choice for families of all races, home languages, incomes, and geographies



Works toward **fair resources for all types of providers**, responsive to family choice



Supports **opportunity, fair compensation, and high-quality working conditions** for the ECEC workforce



Improves **predictability and stability for families, providers, and the workforce**

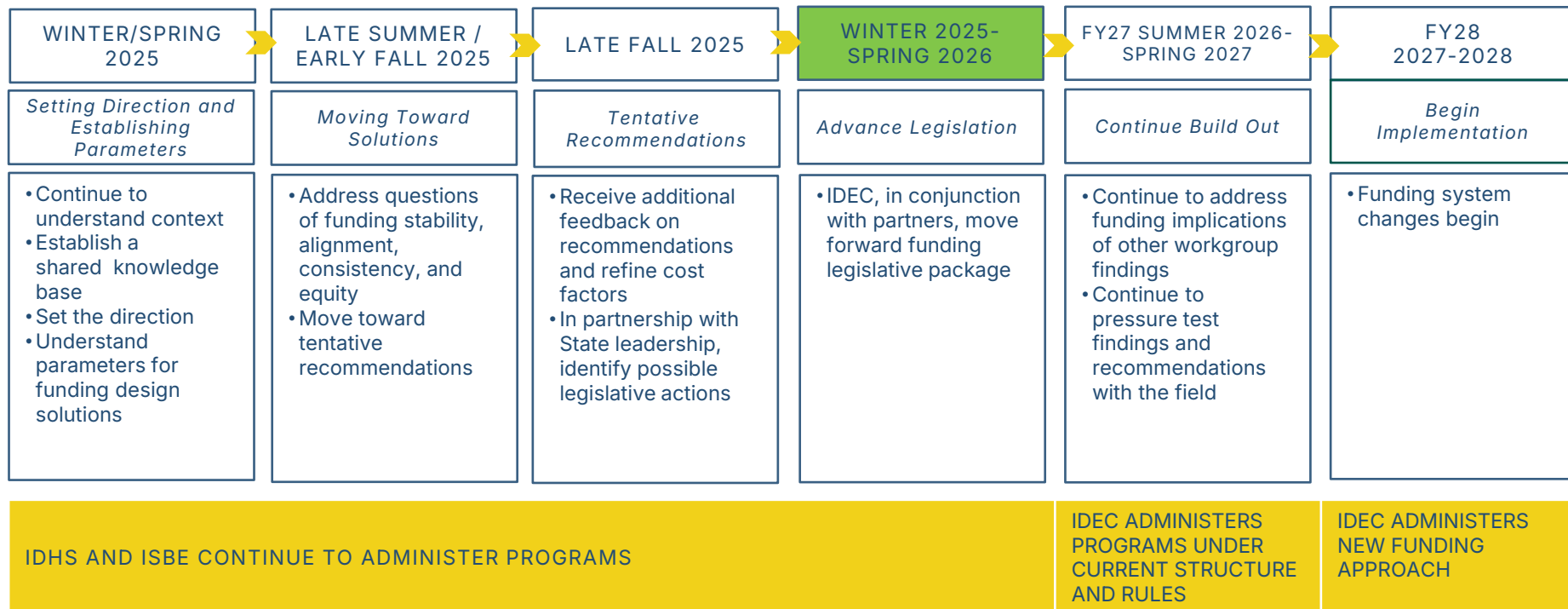


Reduces complexity and burden on ECEC providers



Promotes long-term **system-wide sustainability** through clear and balanced priorities and effective use of all available funds (federal, state, local, and private)

FFN Subcommittee



Essential Questions:

- How can **funding** better reflect the costs of FFN care?
- How do different FFN caregiving arrangements affect the **cost of providing quality care**?
- What support, systems, or funding approaches are needed to ensure **FFN providers can sustain quality care**?

Meeting 1- Dec 11

- **Costs related to the people caring for children:** hours of service, compensation, training
- Costs related to receiving state payment

Discuss emerging recommendations with Funding Design Workgroup

Meeting 2- January 21

- **Costs related to children-** cost differences for caring for multiple children
- Supporting children with disabilities, developmental delays, and multilingual learners
- Costs related to early mornings, overnight and evening/weekend care
- Costs related to supplies- food, housing, laundry, etc.

Key Takeaways from Meeting 1



FFN Subcommittee Key Takeaways



Administrative Tasks and Billing

- **Administrative and billing requirements may be a barrier to FFN participation**, with lengthy applications, background checks forms and processes, and low reimbursement relative to the time and cost required
- **Many FFN providers face time and capacity constraints**, including balancing other jobs, managing reimbursements with limited ability to track payments, and needing additional help navigating technology tools.
- **Peer networks and support from CCR&Rs may be able to help navigate administrative tasks**, but access currently to these supports varies

FFN Subcommittee Key Takeaways Cont.



Training and Professional Development

- **Trainings may be difficult for providers to fit in their schedule**, with many FFN providers completing training on weekends and needing options offered at multiple times and in multiple formats (online and in-person)
- **Access and preferences affect training participation**, as some providers prefer in-person training while others rely on online options, and limited access to technology can be a barrier
- **While training opportunities exist, access is inconsistent**, with caregiving schedules and lack of compensation/incentive affecting providers' participation

Discussion Topics:



Potential Cost Factors:

- ✓ Time required from FFN providers, including hours of care, preparation, training, and professional development
- ✓ Full scope of responsibilities involved in delivering FFN care beyond directly caring for children
- ✓ Administrative processes and time costs related to billing, paperwork, and receiving reimbursement

Discussion: Costs associated with FFN Care



Discussion: What does a typical day look like for an FFN provider?

Tell us about a recent typical day when you cared for children:

- How long was the child/children in your care?
- Did you do anything related to caregiving after the child/children left?
- How do you keep track of the hours and days you care for children? What other tasks do you have to do to get reimbursed?

Discussion: Supplies/Materials Costs

- What kinds of supplies or materials do you regularly buy for the children in your care (for example, food, toys, activities, diapers, etc.)?
- In the past year, have there been times when those costs have increased or decreased?
- How do you pay for these supplies and materials? Are you sharing the cost with the parents, receiving reimbursements, or are parents responsible for bringing supplies/materials?

Discussion: Supporting multiple children, children with disabilities, developmental delays and multilingual learners

Do you care for children within any of the following groups:

- Infants
- Children with developmental delays or disabilities
- Multilingual learners

If so, how does your day look different when caring for a child who needs extra support?

Are there things you pay for yourself to support meeting their needs?

What additional supports might be helpful?

Discussion: Training and Pathways to Licensure

Do you, or have you, participated in trainings or professional development for child care providers?

- If so, what kinds of supports would be helpful to continue to participate in these trainings?
- If not, are you interested in doing so?

If you had the opportunity, would you be interested in becoming a licensed child care provider? Why or why not?
