TAC Equity Framework

An equitable system is one that meets the needs of all children and families, resulting in individual outcomes that cannot be predicted or determined by race, ethnicity, culture, language, gender, religion, orientation, geography, ability, immigration status, housing status, socioeconomic status, or any other protected class or circumstance.

Achieving an equitable system requires a mindset shift that honors and embraces each family's unique racial, ethnic, cultural, linguistic, gender, religious, orientation, geographic, ability and socioeconomic identities, and the intersections between and amongst them. This new way of thinking about how programs, policies and systems can serve children and families simultaneously, views individual and community outcomes in the context of historical exclusion, identifies policies, practices and decisions that create and exacerbate inequities, and dismantles structures that maintain injustices.

Achieving this vision for equity within the context of the transition to the new IL Department of Early Childhood requires all of us to make decisions that prioritize those most impacted by structural racism and systemic inequities. This calls for a strategic approach that aligns and coordinates holistic services and maximizes parental choice to meet the needs of children and the adults in their lives. The process used to achieve this vision should use a variety of mechanisms that are inclusive of local voice and community partners and determined by those most impacted by structural racism and systemic inequities. Analyzing and reporting of disaggregated outcomes is critical to provide transparency about the impact and inform future changes that bring us closer to our vision of equitable family outcomes.



Updating PDAC priorities for FY26

PDAC is an advisory body charged with advising IDHS on IL's professional development system and supports for the early childhood workforce, including Gateways for Opportunity.

- As IDEC engages in redesign work, PDAC is pivoting from its current workplan to support IDEC's priorities and work. This will be important to ensure alignment and avoid redundancies.
- New work may include:
 - Reviewing information from listening sessions and data on credential and training use
 - Mapping the current state of the Gateways Professional Development System, including credentials and training
 - Considering strategies to increase transparency and representation
 - Potentially engaging with the workforce and stakeholders to explore what is working well, rubs, pain points, and wonderings.

Next Steps:

IDHS and IDEC, in consultation with INCCRRA and cochairs, are putting together an uppdated plan for FY2026; intend to reconvene PDAC before the end of the calendar year

Project Background

As early childhood programs and services for young children unify over the transition to IDEC, one of the new agency's top priorities is **reimagining the child care licensing process.** This work is ongoing in addition to technology improvement efforts.

The disparate nature of agencies and programs means families must currently navigate a complex and inefficient system to access services.

IDEC leadership asked Civic Consulting Alliance to support with a review of child care licensing rules and processes from an efficiency and best practices perspective to chart a path forward that prioritizes simplicity and safety.







An important starting point was to establish a vision and supporting design principles to ground the effort

GOAL: Design and advance a comprehensive, equitable model for child care licensing that is safe for families, simpler for providers, and anchored in a continuum of quality.

DESIGN PRINCIPLES

- ✓ **Prioritize quality and safety** considerations to provide best in class experience for families
- ✓ Streamline process to **reduce burden** on providers and licensing staff
- ✓ Update legislation and rules to align to current best practices in childcare
- ✓ Clarify legislation and rules to **reduce complexity** for providers and subjectivity for licensing reps
- ✓ Account for regional, racial, and socioeconomic differences to ensure changes are culturally responsive
- ✓ Invest in **staff development and well-being** to strengthen the workforce and sustain system improvements







The work was divided into three parts and rooted in deep engagement around root causes




To understand the current state of child care licensing in Illinois, the team conducted research and engaged a robust set of stakeholders





Listening sessions engaged over 540 attendees who shared feedback across five categories, leading to four areas to explore further

Process improvement



"The processes for license-exempt care are often confusing and inconsistent, and there is a need for a clear, streamlined process for understanding 'who to go to for what."" —DeWitt County Provider


"Waiting 3-4 weeks for a background to clear is hard to even help providers get licensed quickly or to get the employees when they need them." – Daycare Licensing Representative

Communication and transparency



"Huge gap of who knows that there will be a new agency and who does not know. If someone is not connected with anyone or not in the Facebook groups, they are out of the loop." – Cook County Provider

Structures and support





Technology

"[We need] historical electronic files from last 3 years [to know] what providers had already supplied to licensing application and if there are no changes to their license." — Cook County State Agency Staff

Processes related to background checks and exemptions emerged as the highest priorities for review

External communication, particularly with providers, was identified as most in need of improvement

DCLR structures and support were specifically identified as areas to address first

Being explored and addressed in parallel workstreams





The project team then moved forward looking for solutions to address the pain points identified in those four focus areas

Background checks

Exemptions



DCLR structures and support

Clarify exemptions legislation, rules, and processes to ensure there are clear pathways for providing safe and high-quality child care under different programs to best accommodate families and reduce burden on providers and licensing staff

Provide initial, ongoing, and issue-specific training and ensure clarity in roles and responsibilities in a way that provides consistency and effectiveness across all licensing representatives

Background check sessions focused on delays and inefficiencies, plus the role the State and providers play in the process

Key Questions

What changes based on the current system would improve timeliness and efficiency under IDEC?

Should the background checks process under IDEC be more centralized?

Key Takeaways

- 1) Digitization would solve issues and delays due to manual, paper-based processes and mail submissions
- 2) The benefits may outweigh the drawbacks to centralizing more aspects of the process, particularly linking fingerprints to individuals and having the State adjudicate waivable offenses, and the idea warrants further investigation

The following were identified as next steps for further exploration:

Explore **near-term recommendations** for DCFS:

- Digitize a streamlined 718 form that cannot be submitted until complete
- 2. Increase education to providers around background check process

Explore **centralization** with IDEC transition:

- Link fingerprints to individual applicants instead of providers
- 2. Have State adjudicate waivable offenses







Exemptions design sessions highlighted the need for an updated, nuanced framework based on oversight amid the IDEC transition

Key Questions

Which types of child care programs should be fully exempt from any form of licensure?

Which types of child care programs should have an alternative pathway for licensure (i.e., some requirements)?

Key Takeaways

- 1) There could be value in considering a new exemptions framework centered on levels of oversight (by IDEC or by another agency)
- 2) More work needs to be done to identify where different programming falls in this new framework and what the requirements are for each level of oversight

The following were identified as next steps for further exploration:

- 1. Complete mapping of types of programming to continuum of oversight
- 2. Understand capacity of other agencies for non-IDEC oversight
- 3. Define **requirements and options** for each category, including relationship to funding
- 4. Define internal processes for oversight







External communications design session focused on provider communications

Key Questions

What types of information are important for IDEC to communicate to providers?

How can IDEC implement or improve communication channels?

How can we address pain points by providing supports and tools to ensure consistent and professional customer service?

Key Takeaways

- There are a number of categories of information IDEC should share with providers regularly, including compliance requirements, educational information, and real-time notifications about urgent health and safety updates
- 2) IDEC could also improve on communication channels such as digital resources, live info sessions, direct provider communications, and a centralized customer service hub

The following were identified as next steps for further exploration:

1. Develop implementation plan, including quick wins for near-term implementation and bigger initiatives for longer-term implementation







DCLR structures & support design sessions discussed roles and responsibilities, plus training and resources for DCLRs

Key Questions

How should IDEC support DCLRs to do their jobs effectively and consistently?

How should IDEC strengthen capacity for DCLRs?

Key Takeaways

- 1) Standardization across initial and ongoing trainings, along with sufficient resources for DCLRs, is needed to ensure representatives across Illinois provide consistent information
- 2) Limited staffing capacity can strain workloads and heighten challenges for DCLRs; ensuring adequate staffing and resources for DCLRs will be critical

The following were identified as next steps for further exploration:

- 1. Coordinated overhaul of current onboarding, training, and resources for DCLRs
- Address three main areas to alleviate DCLR workload: ample staffing, tech improvements, and alternative customer service channels

Civic Consulting Alliance and DLA Piper will continue partnering with the IDEC and DCFS teams to reimagine these two processes, which are top priorities for IDEC leadership due to the complexity of the issues and the farreaching impact of solutions


Funding Design Communications Outreach


